Undeclared majors may not take more than 7 credits of special approval courses per quarter. Students who are declared in a major may only take more than 7 credits of special approval courses per quarter with authorization from their department. (Authorization is not required if special approval courses are part of a curriculum approved by CEP, for example the Community Studies major.) The Individual Studies Course class number will be issued by the sponsoring agency at the time the petition is approved. **Completion of enrollment procedures for the course is your responsibility.**
